





Legal troubles mount for former Stormy Daniels lawyer

Avenatti set to square off against SB's Cappello & Noël

Michael Avenatti's rise and fall from grace has been impressively swift.

The George Washington Law School grad appeared a star in the making for his enthuastic representation of porn actress Stormy Daniels, whose real name is Stephanie Clifford, in her March 2018 lawsuit that sought to void a non-disclosure agreement over her alleged 2006 affair with President

Donald Trump. That suit was kicked from federal to California state court last month, though that didn't stop Mr. Avenatti from declaring victory anyway.

"The Court specifically found that Stormy received everything she asked for in the lawsuit — she won," he tweeted on March 7.

In September, Mr. Trump agreed not to enforce the NDA. By December, his former personal attorney, Michael Cohen, was sentenced to three years in prison for financial crimes related to payments made to Ms. Daniels during the 2016 presidential election, to secure her silence about the affair.

During his joyride through American politics, Mr. Avenatti inserted himself into everything from Supreme Court Justice Brett Kavanaugh's confirmation hearings to the 2020 presidential race, albeit briefly.

Never one to shrink from the limelight, he appeared on cable and network news a dizzying 147 times during a 10-week media blitz from March to May 2018, per Media Research Center, the right-leaning media watchdog group.

Around that time, the Hollywood Reporter reported on rumblings of show featuring Mr. A wenatti and short-lived White House Director of Communications Anthony Scaramucci, though Mr. Avenatti denied any interest in TV. The wheels started falling off Mr. Avenatti's public persona in November, when he was arrested by the Los Angeles Police Department on suspicion of domestic violence. Prosecutors decided not to $pursue\,charges\,in\,February\,but\,the$ damage to Mr. Avenatti's political clout was done. Since the domestic violence charges dropped, Mr. Avenatti has been charged by the federal government with bank and wire fraud for allegedly embezzling \$1.6 million of a client's settlement money in order to pay his own expenses and debts and, in a separate case, with attempting to leverage \$20 million from Nike

in exchange for his silence on the company's alleged college basketball recruiting violations.

On Monday, Santa Barbara law firm Cappello & Noël entered the fray, filing a 45-page complaint seeking damages for professional negligence and breach of fiduciary duty on behalf of Mr. Avenatti's former clients William Parrish and Timothy Fitzgibbons. Attorneys from Cappello & Noël declined to comment on the case.

According to the lawsuit, in 2008 Mr. Avenatti's law firm, Eagan Avenatti LLP, represented the plaintiffs in a malicious prosecution lawsuit alongside law firms Panish Shea & Boyle LLP and Stoll, Nussbaum & Polakov, subject to a contingency fee contract.

The plaintiffs' former employer, FLIR Systems Inc. sued the plaintiffs when they left the company to form their own business in 2006 They successfully defended the lawsuit and in 2011, FLIR agreed to pay \$39 million to settle the malicious prosecution case.

Unbeknownst to the plaintiffs the three law firms agreed divide their \$15.3 million share of contingent attorneys' fees subject to their own side agreement.

Stoll attorney Robert Stoll requested the money be deposited into Panish's trust account and not Eagan Avenatti's. The plaintiffs were not notified of this request and on May 31, 2011 the entire \$39 million settlement was deposited into the Eagan Avenatti client trust. The plaintiffs received their share of the settlement proceeds. \$23.5 million, but claim Mr. Avenatti's firm transferred the rest into its operating account, paid Panish's fees from that account at a higher rate than what was agreed in the side agreement, and didn't pay anything to Stoll. The transactions put \$5.4 million worth of fees into dispute, the plaintiffs sav.

"When I see people texting and driving, I only hope that if they crash, they do not make more victims like me," Palos Verdes resident DeeDee Gonzalez said at a Friday morning press conference at Chase Palm Park.

Ms. Gonzalez spoke at a podium set up in front of two totaled vehicles, one caused by an intoxicated driver and another by an "intexticated" one.

In March 2017, Ms. Gonzalez said, she

his spring in Santa Barbara, with wildflower-tripping and resplendent natural color palettes on the collective mind, painter Hank Pitcher's latest exhibition at Sullivan Goss is right on time, and all about place.



'Action painting' a departure from artists normal repertoire

Barbara's south-facing coast. This show, which he calls "Primary" and is one in a periodic series of shows of new work in this downtown art hub, serves various purposes. It is a tribute to timeless natural beauty in our midst, and further proof of the veteran painter's unique touch and voice — a nature worshipping landscape art approach, but one inflected by abstraction and an oblique formality that has come to mark the Pitcher vision.

Significantly, the show is also a timely field report on the well-preserved but fragile place he so eloquently depicts.

Three large canvases — making up a kind of centerpiece trilogy in the show-offer enchanting views of the vast and newly preserved Bixby Ranch property at Point Conception. Software magnates Jack and Laura Dangermond, cofounders of the mapping technology company Esri, purchased the vast, 25,000acred property in late 2017 and donated it to the Natural Conservancv

In Mr. Pitcher's "North Point" series of paintings from the site, populated by exotic plant life and non-native vegetation (which may become history), it's as if the painter himself is a bit bedazzled into creating more dense and Baroque compositions than we're accustomed to seeing from him. The throbbing palette and ornate pictorial designs

lean into the winds of gentle surrealism, while remaining true to realistic form on site.

In these new paintings, the art ist is up to his aesthetic business of splitting differences and elements of painterly style, without calling un due attention to the process. The ap proach remains unified, painterly and with an appeal both direct and undercoated by mysterious aspects beyond first impressions of a painting at hand.

Generally, in Pitcher's panting world, animate beings are left out of his art, apart from the surro gate figurative presences in his by-now classic "surfboard portraits' (the token example in this show is the sleek, life-size "HGD a Sands").

But in the show "Primal," there are exceptions. Cryptic, small paint ings of ominous turkey vultures, tarry and shadowy in their silhouette presentation, document a rare vulture sighting at the Point Conception site.

More dramatically, a sense of life in furtive motion is the very core of an unusual piece for Mr. Pitcher the striking "Bees and Wild Rad ishes.

In this long, three-panel "action painting," the principle, primal ac tion is that of the protagonist bees in the foreground of a meadow scene.

These are busy, buzzy bees, their work frozen in crisp focus, contrasting the soft-edged background in a shallow depth of field, making for a sly photography reference folded into the painters' optica tactics

The fact that bees are facing a curious wave of endangerment, threat ening to disrupt natural life cycles validates the artist's underlying ecological concerns and chronicles But the painting itself, in artistic terms, reminds us that this is a painter both established and open to evolution. He's an artist with a lot on his mind, and in his eye, and with some serious deep root sys tems going.



fees into its operating account, the money was used to benefit Mr. Avenatti and others at the firm.

"By improperly transferring the Disputed Fees from the client trust account and commingling them with funds in the operating account, the (Eagan Avenatti) Defendants obtained an adverse pecuniary interest to the Clients as this exposed the Clients to a potential lawsuit for fees the Clients owed under the Joint Retainer and already had paid to the Attorneys, jointly," read the complaint.

The plaintiffs say Mr. Avenatti failed to inform them they could be liable to Stoll for unpaid fees, and that he concealed the fact that he unilaterally transferred the disputed funds into his firm's operating account.

They are seeking compensatory damages, for fees incurred in retaining unconflicted counsel to defend them in a lawsuit brought by Stoll, and punitive damages.

Eagan Avenatti represented the plaintiffs in the Stoll lawsuit until their conflicting interests were discovered in August 2018.

"In 2011, I obtained the largest malicious prosecution settlement in the history of California for the clients. It was a tremendous result by any stretch of the imagination That old adage 'No good deed goes unpunished' has never been more true," Mr. Avenatti said Wednesday in an email to the News-Press.

'The settlement was almost 8 years ago. It is odd that we are just now hearing them complain."

The statute of limitations for legal malpractice is one year from discovery and a maximum of four years from the wrong, according to the California Code of Civil Procedure.

Plaintiffs say they are exempt from the statute of limitations because they incurred new damages when they engaged new counsel in 2018
